The Oberoi Group Announces Two New Resorts in Rishikesh in Partnership with The Ladhani Group

New Delhi, Monday, 3 March, 2025: In keeping with EIH Ltd.'s strategic expansion, The Oberoi Group is pleased to announce the addition of two new resorts in Rishikesh. A 17% YoY RevPAR growth in Q3 for domestic hotels (owned & managed) further reinforced the company's leadership in luxury hospitality. The Q3 results have been achieved despite closure of The Oberoi Grand for complete restoration.
